A matter can be linked to only 1 matter container, where the later can have many matters. The "Matter Container" object was enhanced to add more context to it (client name, open date, closed date, etc.), moreover, when creating a matter from within the "Matter Container" all the meta data will be inherited by the new matter.
Improve ment	"Content Language" in Money Module	The switch content language in the money module now affects all the fields in the application as well as in the exported documents. No need to switch the content language and application interface language to get an export of your invoice in a specific language.
Improve ment	Invoice Template	The invoice template has been fine tuned with minor enhancements to make the exported document more organize (consistent fonts, better spacing,etc..)
Improve ment	Group Events in Activies Tab	In the activities tab of a litigation case, all the events and sub-events are grouped under "Events"
