- Improvement: The Task has a new option (Task Metadata) to restrict who can modify a Task's metadata.
- UX: Timer stop screen now supports setting the time log status (Billable/Unbillable)
- Hearing time is now defaulted and set as a required field for more accurate data capture.
- Improved the Hearing Grid & Hearing Reports performance for large data sets
