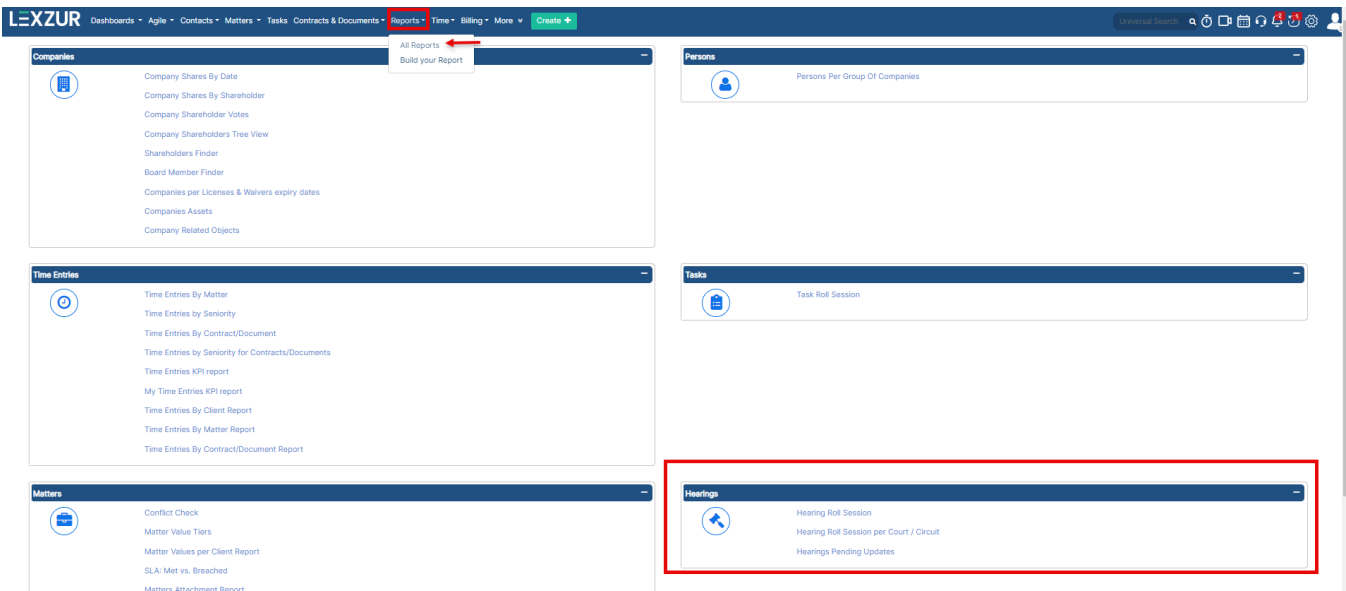
Objectives
