When adding a new entry, there are 4 required fields:

- **Type:** type of the license, which is a customizable list. For example: Trade License.
- **Released on:** specify the released date.
- **Expires on:** specify the expired date.
- **User to remind:** select a user to remind or a group of users.

You can also add other fields like the:

- **Reference Number**
- **License Activity:** the activity of this license (Business Licensing, Software Licensing, etc.)
- **Managers:** It could be a Person or a Company
- **Permissions:** Choose the allowed permissions from a drop-down menu



Once the user inserts an entry with an expiry date, an automatic Reminder is created for the associated user or group of users in the reminder tab.
