- Send the report directly to the client

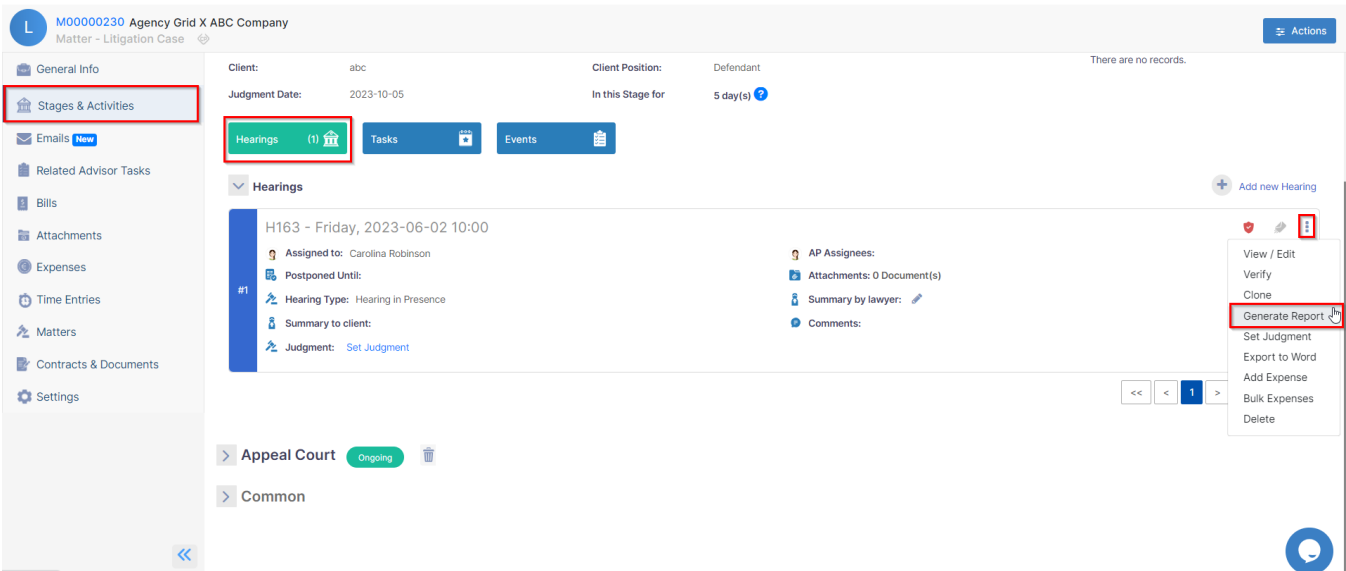
Steps

In LEXZUR, you can create and send a hearing report to your client.

Client reporting enables you to regularly interact with your client and helps you educate your client on what you do.


Open the Litigation Case, then from the **Stages & Activities** tab choose the **Hearing** you wish to send.

From the 3 dots at the level of the hearing, click **Generate Report**



From the Hearing Report Generator, you can choose a template from the list that you have already added.



 The templates can be customized depending on your needs, so you can create your own with the information you need to send and use it while generating reports. [Learn more here.](#)

The system will automatically fetch the hearing's data based on your template. The report is now ready; you can give it a new name, download it, or send it to your client.
